# **Generic Marking Principles**

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptors for a question. Each question paper and mark scheme will also comply with these marking principles.

#### GENERIC MARKING PRINCIPLE 1:

Marks must be awarded in line with:

- the specific content of the mark scheme or the generic level descriptors for the question
- the specific skills defined in the mark scheme or in the generic level descriptors for the question
- the standard of response required by a candidate as exemplified by the standardisation scripts.

#### GENERIC MARKING PRINCIPLE 2:

Marks awarded are always whole marks (not half marks, or other fractions).

#### **GENERIC MARKING PRINCIPLE 3:**

# Marks must be awarded **positively**:

- marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit
  is given for valid answers which go beyond the scope of the syllabus and mark scheme,
  referring to your Team Leader as appropriate
- marks are awarded when candidates clearly demonstrate what they know and can do
- marks are not deducted for errors
- marks are not deducted for omissions
- answers should only be judged on the quality of spelling, punctuation and grammar when these features are specifically assessed by the question as indicated by the mark scheme. The meaning, however, should be unambiguous.

### **GENERIC MARKING PRINCIPLE 4:**

Rules must be applied consistently, e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

## **GENERIC MARKING PRINCIPLE 5:**

Marks should be awarded using the full range of marks defined in the mark scheme for the question (however; the use of the full mark range may be limited according to the quality of the candidate responses seen).

#### GENERIC MARKING PRINCIPLE 6:

Marks awarded are based solely on the requirements as defined in the mark scheme. Marks should not be awarded with grade thresholds or grade descriptors in mind.

# General levels of response

Process for awarding marks:

- Markers review the answer against the AO4 marking criteria, and award a mark according to these criteria.
- Generally, the subsequent mark awarded for AO1 will be the same level. In exceptional cases, markers could award marks in different levels for the two AOs. This is because the ability to recall, select and deploy relevant historical material will be central to any effective analysis and evaluation of the interpretation.
- Responses that focus on contextual knowledge without reference to the interpretation cannot be rewarded.

Underlining is used in this mark scheme to indicate the main interpretation of the extracts.

1	The Origins of the First World War	40
	Interpretation/Approach	
	The Key Question to be addressed is 'Who (or what) was to blame for the First World War?'	
	The main interpretation is that there was no real intent to cause a general war in 1914, but decision-makers were powerless to resist what seemed to them the inevitable logic for war implicit in the alliance system. Showing complete understanding of the Interpretation will involve discussion of both these aspects. The historian believes that war was effectively inevitable because everyone thought it inevitable. Events assumed a momentum which no-one could stop. The picture offered of the great powers is unflattering – incompetent, ignorant, at the mercy of events. Blame, in this context, is focused on the alliance system, rather than one a particular individual or nation.	
	Glossary: Early post-First World War interpretations tended to blame Germany, but quickly a reaction against this occurred, with a variety of interpretations blaming other nations. This may be termed revisionism. The turning point in the historiography was Fischer's work of the early 1960s which went back to blaming Germany – sometimes known as antirevisionism. Since then, there has been a vast variety of interpretations, looking at the importance of culture, individuals, contingent factors etc, with no clear consensus, though most historians would still place a significant burden of responsibility on Germany.

2	The Holocaust	40
	Interpretation/Approach	
	The Key Question to be addressed is 'Why did the Holocaust occur?'	
	The main interpretation is that Nazi genocide rested on 'scientific' ideas that had developed over many years and been adopted into Nazi racial policy, and that al the excluded groups were treated in the same way. Showing complete understanding of the Interpretation will involve discussion of both these aspects. The historian adopts an approach to the Holocaust that does not limit the victims to Jews alone. Rather, the Nazi policy of exclusion applied equally to each of the groups, and even before war started was extended to include killing. This interpretation puts genocide into an historical context broader than the Nazis alone, but nonetheless still makes clear their intention first to persecute, and then, when the opportunity arose, to murder. The war is mentioned as providing opportunity for the Nazis to do what they anyway intended, and not as a cause in its own right of the Holocaust. The only acceptable 'label' at L5/L6 is intentionalism. 'Synthesis' could be L4 if the intentionalist element is explained. Functionalism and structuralism will be L3 max.	
	Glossary: Candidates may use some/all of the following terms: Intentionalism – interpretations which assume that Hitler/the Nazis planned to exterminate the Jews from the start. Structuralism - interpretations which argue that it was the nature of the Nazi state that produced genocide. There was no coherent plan but the chaotic competition for Hitler's approval between different elements of the leadership produced a situation in which genocide could occur. Functionalism sees the Holocaust as an unplanned, ad hoc response to wartime developments in Eastern Europe, when Germany conquered areas with large Jewish populations. Candidates may also refer to synthesis interpretations, i.e., interpretations which show characteristics of more than one of the above. What counts is how appropriate the use of this kind of terminology is in relation to the extract, and how effectively the extract can be used to support it.

3	The Origins and Development of the Cold War	40
	Interpretation/Approach	
	The Key Question to be addressed is 'Who (or what) was to blame for the Cold War?'	
	The main interpretation is that Stalin was personally responsible for the Cold War because i) he was an ideologically driven expansionist, and ii) he made mistakes and misjudgements in his dealings with the West. Showing complete understanding of the Interpretation will involve discussion of both these aspects. The focus on ideology and on Stalin mark this out as a post-post-revisionist interpretation, which is the only label that can be rewarded in L6. Traditionalist/orthodox can be given L5 if dealing with at least one aspect of the main interpretation. Post-revisionist will be L4 if the aspect blaming Stalin is properly explained. L3 for revisionism and any other approaches missing the main interpretation.	
	Glossary: Traditional/Orthodox interpretations of the Cold War were generally produced early after the Second World War. They blame the Soviet Union and Stalin's expansionism for the Cold War. Revisionist historians challenged this view and shifted more of the focus onto the United States, generally through an economic approach which stressed the alleged aim of the US to establish its economic dominance over Europe. Postrevisionists moved towards a more balanced view in which elements of blame were attached to both sides. Since the opening of the Soviet archives post-1990 there has been a shift to attributing prime responsibility to Stalin – a post-post-revisionist stance which often seems very close to the traditional view, but which often places great importance on ideology. What counts is how appropriate the use of this kind of terminology is in relation to the extract, and how effectively the extract can be used to support it.
