- (a) Explain why Austria lost the war of 1866 against Prussia. [10]
- (b) How far were the revolutions in Germany, 1848–49, caused by nationalism? [20]

**3 The Russian Revolution, 1894–1921**

- (a) Explain why there was opposition to the introduction of the New Economic Policy. [10]
- (b) 'Disunity amongst its critics kept the Tsarist regime secure in the period 1906–14.' How far do you agree? [20]

- (a) Explain why ex-slaves found it difficult to improve their lives during the Reconstruction period. [10]
- (b) How important was foreign influence in determining the outcome of the Civil War? [20]

- (a) Explain why there was a 'Roosevelt Recession' in 1937–38. [10]
- (b) How far do you agree that the Depression was caused by Hoover's reaction to the Great Crash? [20]

- (a) Explain why the Kellogg–Briand Pact of 1928 was seen as a major development in international relations. [10]

- (a) Explain why Britain was slow to begin rearmament in the 1930s. [10]
- (b) ‘The Nazi–Soviet Pact was brought about by Stalin’s mistrust of Britain and France.’ How far do you agree? [20]

**9 China and Japan, 1912–45**

- (a) Explain why the Japanese army occupied Manchuria in 1931. [10]
- (b) To what extent was the increasing support for the Chinese Communist Party in the 1930s a result of the policies of Chiang Kai-shek? [20]
