## **Generic Marking Principles**

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptors for a question. Each question paper and mark scheme will also comply with these marking principles.

GENERIC MARKING PRINCIPLE 1:

Marks must be awarded in line with:

- the specific content of the mark scheme or the generic level descriptors for the question
- the specific skills defined in the mark scheme or in the generic level descriptors for the question
- the standard of response required by a candidate as exemplified by the standardisation scripts.

GENERIC MARKING PRINCIPLE 2:

Marks awarded are always whole marks (not half marks, or other fractions).

GENERIC MARKING PRINCIPLE 3:

Marks must be awarded **positively**:

- marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit
  is given for valid answers which go beyond the scope of the syllabus and mark scheme,
  referring to your Team Leader as appropriate
- marks are awarded when candidates clearly demonstrate what they know and can do
- marks are not deducted for errors
- marks are not deducted for omissions
- answers should only be judged on the quality of spelling, punctuation and grammar when these features are specifically assessed by the question as indicated by the mark scheme. The meaning, however, should be unambiguous.

GENERIC MARKING PRINCIPLE 4:

Rules must be applied consistently, e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

GENERIC MARKING PRINCIPLE 5:

Marks should be awarded using the full range of marks defined in the mark scheme for the question (however; the use of the full mark range may be limited according to the quality of the candidate responses seen).

GENERIC MARKING PRINCIPLE 6:

Marks awarded are based solely on the requirements as defined in the mark scheme. Marks should not be awarded with grade thresholds or grade descriptors in mind.

	<ul> <li>(Using data encryption is) a way to keep their data secure//to protect their information from a hacker_//to safely exchange data (1)</li> <li>Information needs to be impossible to understand/unreadable/indecipherable (1)</li> <li>Information needs to be useless to a 3<sup>rd</sup> party if intercepted/hacked/they should not have it (1)</li> <li>Only authorised people/people with the key can understand the information (1)</li> <li>Encrypted data needs to be decrypted which is hard/impossible (without the key) (1)</li> <li>To make hacking not worthwhile (1)</li> </ul>

	<ul> <li>Uses email to collect/gather/persuade to give <u>personal information/data</u> (award any concept of 3rd party getting access to personal data) (1)</li> <li>Any statement that email or website look legitimate/real, <b>but</b> is/are in fact fake/from a hacker/criminal (1)</li> <li>The email usually contains something that demands the target's (immediate) attention (1)</li> <li>Any suitable example of a message/scenario demanding attention (1) <ul> <li>EITHER</li> <li>The email may ask customer to <u>reply</u> (1)</li> </ul> </li> </ul>	
	<ul> <li>Target asked to enter their information (1)</li> <li>OR</li> <li>The email <u>includes</u> a website URL/link (inviting the receiver to go to the site) (1)</li> <li><u>Clicking on/opening the link</u> takes them to a <u>fake/malicious</u> website (1)</li> <li>Target asked to enter their information (1)</li> </ul>

	<ul> <li>Some people in developing countries have no actual postal address making the delivery of goods which are purchased online difficult (1)</li> <li>Many people in developing countries have no access to broadband so speed of purchase is slower (1)</li> <li>Many people in developing countries have no PCs/laptops/smartphones/tablet computers so need to borrow a PC/go to a library (1)</li> <li>In developing countries power outages can mean that connection is lost during the process and so have to start again/lose the sale (1)</li> <li>Many people in developing countries do not have bank accounts and credit cards so have to organise for someone else to buy the product on their behalf (1)</li> <li>In many developing countries, goods bought using the internet are not covered by consumer-protection laws so people have no protection from unscrupulous sellers (1)</li> </ul>

9(a)	<ul> <li>FOUR from:</li> <li>A (standalone) malicious computer program/code (1)</li> <li>A program that replicates itself in order to spread to other computers (1)</li> <li>Does not need to attach itself to an existing program/file (1)</li> <li>Worms consume bandwidth, slowing down the (traffic in a) network (1)</li> <li>Worms consume processing power, therefore (e.g.) slowing down computer operation/system//stopping the computer from operating (1)</li> <li>A worm exploits (security) holes in networks/computers (1)</li> <li>They replicate themselves occupying (more) space (1)</li> <li>Can modify/delete files//bring other (malicious) software//install backdoor (1)</li> </ul>	4
9(b)	<ul> <li>FOUR from:</li> <li>A malicious computer program which is used to hack into a computer (1)</li> <li>Misleads users of its true intent/disguises itself as authentic software (1)</li> <li>Enables the person who created it to take control of the computer it has infected (1)</li> <li>Trojans (generally) do not attempt to infect other files (1)</li> <li>They do not attempt to self-replicate themselves (1)</li> <li>Has to be/is activated by (e.g.) the target person (1)</li> <li>ONE mark for any further action a Trojan may perform (1)</li> <li>e.g.</li> <li>Provide a backdoor onto your computer so a 3rd party can take control</li> <li>Delete files from the hard disk</li> <li>Copies data/files</li> <li>Can corrupt data (damage = TV)</li> </ul>	4

10	<ul> <li>Max four from:</li> <li>A format used for storing data, for anyone to use (1)</li> <li>An open-source file format can be used by both proprietary and (free and) open-source software (1)</li> <li>Open source formats are often called free file formats if they are not covered by any copyrights/patents (1)</li> <li>Anyone may use them at no cost (1) for any desired purpose (1)</li> <li>Code is open to inspection (1)</li> <li>Code can be amended without breach of copyright (1)</li> </ul>	5
	<ul> <li>Max three from:</li> <li>Needed because not everyone can afford proprietary software (1)</li> <li>Needed so users can work on files in different locations without the need for the same software (1)</li> <li>Provides a standard file type (1)</li> </ul>
