Visitor attractions in the United Kingdom (UK)

Tourism is the fifth largest industry in the UK.

The most popular visitor attractions in the UK welcomed 45.4 million visitors during 2020. This was a decrease of 70% from 151.3 million visitors in 2019.

In 2020, there was a global pandemic. This caused the UK's international borders to be closed for non-essential travel. The population of the UK were also asked to stay at home for most of the year.

As a result of this, many indoor visitor attractions were forced to close for safety reasons. However, outdoor attractions were able to open for a few months of the year during the summer season. It was only in the summer months, June to September, that domestic tourism was allowed.

The UK government provided financial support for UK attractions so they could survive this long period of time without any tourists.




