

## Answer Question 1.

Participant observation is a method where researchers join the group being studied. This method not only allows the sociologist to observe people in their natural setting, but also to understand and feel things from their point of view. One issue to address is whether the research will use overt or *covert observation*. A key strength of participant observation is that it allows the sociologist to achieve a rich and detailed picture of the study group and obtain data that is high in validity.

Interpretivists are most likely to support the use of observation, which can be participant or non-participant. On the other hand, those who favour a positivist approach are critical of observation. They point to a number of ethical, practical and theoretical problems with observational methods.
