(c) Interest cover shows how many times interest payments are covered by operating profits cover has improved (1) and interest charges are still comfortably covered (1) increased by 1.2 times (1). Earnings per share shows how much profit (after interest, tax and preference dividends) is attributable to each ordinary share the ratio is used as a convenient measure of success. The ratio has improved (1) by 2 cents in the second year (1 of). Price earnings ratio relates the market price of a share to its earnings. There has been a slight improvement (1) indicating greater confidence of Investors in the company (1).

Dividend yield expresses the dividend as a percentage of the market price of a share this will indicate to investors how much they can expect as a return on each \$ invested.

There has been an improvement (1) of about 50% (1 of) over the year.

Dividend cover shows how many times the ordinary dividend can be paid out of profits after interest, tax and preference dividends. There has been a deterioration (1) of about 1/3 this year which might indicate that future dividends might be at risk (1).
