## **General Marking Guidance**

- All candidates must receive the same treatment. Examiners must mark the first candidate in exactly the same way as they mark the last.
- Mark schemes should be applied positively. Candidates must be rewarded for what they have shown they can do rather than penalised for omissions.

- Where some judgement is required, mark schemes will provide the principles by which marks will be awarded and exemplification may be limited.
- When examiners are in doubt regarding the application of the mark scheme to a candidate's response, the team leader must be consulted.
- Crossed out work should be marked UNLESS the candidate has replaced it with an alternative response.

Where candidates have referred to all 3 bullet points, a maximum mark of 5 is available to candidates.  Where candidates have only referred to 2 bullet points, a maximum mark of 4 is available to candidates.  Where candidates have only referred to 1 bullet point, a maximum mark of 3 is available to candidates.  Where candidates have either lifted their response entirely from the text or lifted mainly from the text and inserted their own isolated words and/or short phrases a score of zero is given for LAR and GAR. In both these cases the candidate has not produced enough of his/her own work for it to be rewarded for these 2 traits.  Where candidates have attempted to either reformulate the text or use their own words, a minimum mark of 1 becomes available for LAR and GAR.	(20)

#### **Indicative content:**

 give two ways in which the sense of smell differs between dogs and humans

dogs have a better sense of smell than humans; this sense is much more developed in dogs; dogs are able to acquire a lot of information through smell; in terms of smell, a dog's brain is more developed than a humans

 give two ways in which dogs have better hearing than humans

dogs can hear noises from further away; can hear higher frequencies of sound; useful for hunting prey and working dogs

• give **one** way in which the sense of sight differs between dogs and humans

humans see better than dogs; dogs see a limited range of colours compared to humans; dogs cannot see textures or detail well; dogs are better at seeing in the dark and spotting moving objects; some dogs have good long-distance vision
