#### Task 2 - Document

You are going to edit a report for Tawara Yacht Brokers. The company uses a corporate house style for all their documents. Paragraph styles must be created and applied as instructed.

1 Using a suitable software package, open the file SP02SUPER.rtf

The page setup is set to A4, landscape orientation with 2 centimetre margins. Do not make any changes to these settings.

Save the document in your work area with the filename **BROKER** 

Make sure it is saved in the format of the software you are using.

Place in your Evidence Document a screenshot to show this file has been saved. Make sure there is evidence of the file type.

### 2 Place in the footer of the file BROKER

- automated page numbers left aligned
- your name, centre number and candidate number right aligned.

### Make sure that:

- all the alignments match the page margins
- no other text is included in the header and footer area
- the footer is displayed on all pages.

- **22** Using fields from both tables, produce a tabular report that:
  - selects the records where:
    - Build Year was after 2010
    - Length is 40 or less
  - contains a new field called **Total\_Berths** which is calculated at run-time. This field will add the *Sleeps* field to the *Crew* field
  - shows only the fields Yacht\_Name, Builder\_Name, Type, Length, Price, Build\_Year, Build\_Country, Sleeps, Crew and Total\_Berths in this order with data and labels displayed in full. Do **not** group the data
  - sorts the data into ascending order of *Type* and then descending order of *Length*
  - has a page orientation of landscape
  - fits on a single page wide
  - includes the heading Yachts less than 15 years old as a title displayed in a larger font size at the top of the page
  - has your name, centre number and candidate number in the footer of the report so it displays on every page.

Save and print your report.

- **23** Using fields from both tables, produce a tabular report that:
  - selects only those records where
    - Country\_Code is NZ or AU
    - Builder Name includes the text Yacht
  - shows only the fields Yacht\_Name, Builder\_Name, Type, Length, Price and Build\_Country in this order with data and labels displayed in full. Do **not** group the data
  - sorts the data into descending order of *Price*
  - has a page orientation of portrait
  - fits on a single page
  - calculates the average *Length* in this selection and positions this number below the *Length* column
  - displays this average length value to 1 decimal place
  - includes the heading Oceania Boat Builders as a title displayed in a larger font size at the top of the page
  - has your name, centre number and candidate number at the top or bottom of the report.

Save and print your report.

Unless otherwise instructed, the slides must display a title and a bulleted list.

  - automatic slide numbers on the top right
  - your name, centre number and candidate number.

Make sure that:

- master slide items appear in the same position on every slide
- no items overlap on any slide.

- 28 On the slide with the title *Marketing* demote the 4 bulleted items after the text *dedicated marketing manager*: so they look like this:
  - dedicated marketing manager:
    - manages vessel's promotion on specialist websites
    - keeps all particulars up-to-date in real time
    - maintains social media interaction and messaging
    - monitors market trends and fluctuations

- 29 Use the data in the file **SP02SALES.csv** to create a vertical bar chart to compare the sales of yachts by size for only the year 2021. Display, with labels, the yacht lengths on the category axis and the number sold on the value axis. [2]
- 30 Label the chart as follows:

chart title Superyacht Sales 2021 value axis title Number Sold category axis title Length (Metres)

31 Display only the values as data labels above each bar.

Do **not** display a legend.

**32** Format the value axis scale to display:

a minimum value of **0** a maximum value of **120** increments of **15**

33 Place the chart to the left of the bullets on the slide with the title Sales.

Make sure that:

- no words are split
- all data and labels are fully visible
- the chart and its content do **not** overlap any slide items.

34 On the slide with the title *Our Services* format the text *yacht charters* so that when clicked it goes to the slide with the title *Sales*.

Take screenshot evidence to show that the text links to the correct slide. Place this in your Evidence Document.
